License Agreement

1. **LICENSE.** Page Technology Marketing, Inc., ("PTMI") grants a license to the user (the individual and/or corporate licensee) to use the Program Product (the set of computer programs, and machine readable and printed materials supplied with this package) and the output of the Program Product in the form of Converted Typeface Files or "CTF" (the computer files created as the output of AllType for use with other software application programs and printers containing converted copies of original typefaces from other vendors in their proprietary formats) for a term beginning on the date you accept this Agreement and continuing until termination. This license agreement is automatically terminated if you violate any of the terms and conditions of this license agreement except that the "COPY RESTRICTIONS" shall survive any such termination, regardless of the reason of termination. You may terminate this agreement at any time by destroying all copies, modifications, CTF's and original materials supplied with the Program Product.

2. **OWNERSHIP.** As the User, you own the magnetic or other physical media on which the PTMI Product is originally or subsequently reordered or fixed, but PTMI retains the title to and ownership in the software program of the PTMI Product recorded on the original disk copy and all subsequent copies of the PTMI Product, regardless of the form or media in or on which the original and other copies may exist. This license is not a sale of the original software program of the PTMI product or any portion or copy of it.

3. RESTRICTIONS.

3.1 **GENERAL RESTRICTIONS.** You may not use, copy, modify, merge or transfer the Program Product or the Converted Typeface Files produced or any portion or modification thereof in whole or in part, except as expressly provided in this agreement. This license does not transfer any right, title or interest in the PTMI Program Product or the CTF's produced to you except as specifically set forth herein. You are hereby notified that PTMI claims protection of and has ownership of the Program Product, CTF's and original typefaces under trade secret and copyright laws.

3.2. **COPY RESTRICTIONS.** The PTMI Product, the CTF it creates, and the accompanying materials are copyrighted and contain proprietary information and trade secrets of PTMI. Unauthorized copying of the PTMI Product or its CTF, even if modified, merged, or included with other software, or of the written materials is expressly forbidden. You may be held legally responsible for any infringement of PTMI's intellectual property rights that is caused or encouraged by your failure to abide by the terms of this Agreement. You may make one (1) copy of the PTMI Product or the CTF's it creates solely for backup purposes provided the copyright notice is reproduced in its entirety on the backup copy.

4. PERMITTED USES.

4.1. **USE OF THE PROGRAM PRODUCT.** You may use the Program Product on any one (1) personal computer, workstation or functional equivalent. You do not have the right to make unlimited copies of this software, as it is protected by computer software copyright laws. The single backup copy is for personal use by the Licensee only, and any additional copies are unlawful without the written permission of PTMI. It is also illegal to use this product on more than one machine at a time. You may not modify, adapt, translate, reverse engineer, decompile, disassemble, or create derivative works based on the PTMI Product except as specifically set forth in this agreement.

4.2. **USE OF THE CONVERTED TYPEFACE FILES.** Converting copyrighted typefaces for the purposes of resale, copyright infringement or licensing avoidance is strictly prohibited. Refer to your original typeface Licensor's Program License Agreement for additional restrictions that may apply. You do not have the right to make unlimited copies of the CTF's created by this software, as it is protected by computer software copyright laws. You will be held responsible by the Licensor of the typeface for any infringement of the terms, rights and limitations governing the use of the typeface in its original form.

4.2.1. The user may use the CTF's created by the Program Product on only one (1) printer at a time and the user may not reformat or decompile any CTF for any purpose.

4.2.2. A separate license agreement and fee is required if you wish to use the CTF's from the PTMI Program Product on more than one (1) printer or one (1) computer.

4.2.3. The CTF's may not be duplicated or copied except for one copy of each file for archival purposes. All copies must remain in your possession and bear copyright notices contained in the original and transferred into the Converted Typeface File.
